- 1. Section 5.01 of the By-laws was changed to read that all checks will be signed by "the Treasurer, or his designee, and by another member of the Board."
- 2. Section 1.04 was discussed. The State Librarian affirmed that the Pennsylvania Library Code should be regarded as a guideline to the many and diverse public libraries in the Commonwealth. In a motion made by Jane Gill, seconded by Olga Negrón, and passed by majority, the By-laws will be changed to read "Bethlehem Area Public Library is guided but not controlled by Pennsylvania Library Code."
- 3. In a motion made by Jane Gill, seconded by Olga Negrón, and passed by majority, Section 2.03 of the By-laws will be changed to read the Board of Trustees will consist of "seven members appointed by the City of Bethlehem, two members appointed by Bethlehem Township, one member appointed by Hanover Township, and one member appointed by the Borough of Fountain Hill." The next U.S. census will be reviewed to determine if the numbers should change.
- 4. Thomas Nolan reminded the trustees to consider attending the Trustee Training opportunity scheduled for August 12.

Jack Nagle made a motion to adjourn. The meeting was adjourned at 8:00 p.m. The next meeting date is July 10.
